Much of what we've learned about COVID-19 indicates that it is an infectious disease primarily transmitted through respiratory droplets produced when an infected person coughs or sneezes; as such, OSHA has included COVID-19 in their Bloodborne Pathogens standards as it relates to training and exposure control and prevention of infection. In response to these changes, MER's Health and Safety Team has reviewed and updated our existing Bloodborne Pathogen safety and training programs along with related standard operating procedures and job hazard analyses to ensure that the inclusion of COVID-19 related information and protocols are in accordance with current regulatory standards and guidance made by US regulatory agencies such as the CDC and OSHA. MER has fully trained HAZMAT teams in all of our operational regions and has the required capabilities to respond to suspected or confirmed COVID-19 contamination incidents.


